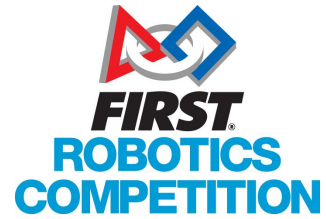

# What is “safety?”

According to Merriam-Webster...

/saftə/

Noun

1. The condition of being protected from or unlikely to cause danger, risk, or injury.

Synonyms: welfare, well-being,  
protection, security

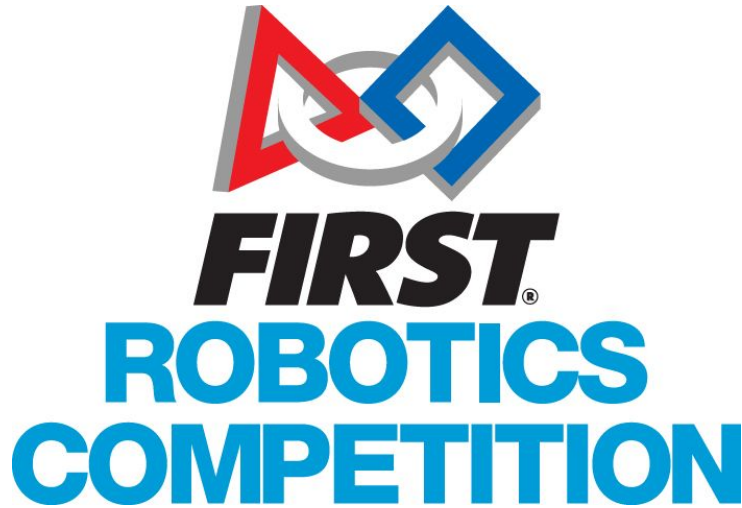

# Why is Safety Important?

1. To protect ourselves from danger
2. To protect others from danger
3. To maintain proper care of equipment in the shop to ensure that it lasts longer



# That's what FIRST says...



“Instilling a culture of safety is a value that every individual in the FIRST community must embrace as we pursue the mission and vision of FIRST. FIRST Robotics Competition has adopted safety as a core value and has established the framework for safety leadership in all aspects of the program.”

# Safety in the 2080 Engineering Shop

Protective eyewear MUST be worn in the following situation:

1. Whenever work is being done on the robot (grinding, drilling, soldering, cutting, welding, etc.)
2. Whenever programming is being done and tested on the robot...RULE OF THUMB: If the robot parts need to move, your eyes need to be covered.
3. Whenever driving the robot...or you are near the driving robot...SEE RULE OF THUMB
4. Whenever there is risk of flying particles or chemical exposure.



# Personal Protective Equipment (PPE)

Protect MORE than just your EYES...

**Hand Protection:** Torbotics maintains a supply of gloves to protect you against heat, electrical, chemical & mechanical hazards.

**Hearing Protection:** Torbotics maintains a supply of hearing protection devices (EARPLUGS) to be used when there are high sound levels present in the shop.

**Foot Protection:** Whenever the shop is in use, closed-toes shoes must be worn.



# Tool Safety



## ALL TOOLS

- **MUST** be put back in their place when you are finished using them. (It slows down the robot build when we have to search for parts that were not put up correctly.)
- Safety training logs are located next to **EACH PIECE** of machinery in the shop.
- **ONLY** team members who are logged as trained on the machine can use it.
- **NEVER** carry unshielded tools in your pocket.
- Never use any safety equipment **WITHOUT** safety guards in place.
- Once you are done using a machine it **MUST** be unplugged.
- **DON'T LEAVE** tools on overhead work spaces where they can be knocked off and strike someone below.

# Robot Safety

Any team member helping with transporting the robot should be trained on proper lift procedures.

The robot should be powered OFF when lifting.

Team members and mentors need to be a safe distance away from the robot BEFORE it is enabled.





# Battery Safety



Batteries are dangerous and should always be handled with care.

In the bottom of the battery cart there is a battery spill kit which should be used any time a battery spills or leaks battery acid.

Do NOT place liquids near the battery cart or batteries at any time.

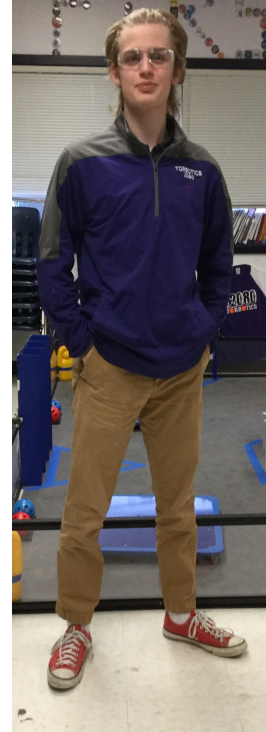
Do NOT leave the batteries charging overnight.

# Other Safety Considerations

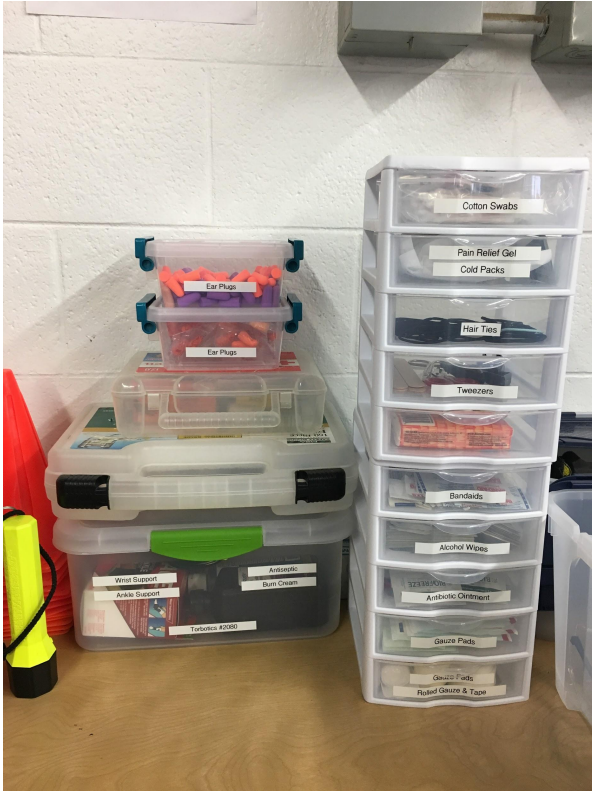
During robot build and machinery use:

- Long pants should be worn.
- You cannot wear hanging jewelry.
- Any drawstrings on jackets or hoodies must be tucked.
- Long hair must be pulled back with a hair tie (and headband, if needed).
- Do not run in the shop.
- No horseplaying in the shop.

Even if you do not plan to be a part of the build on any given day, you must still follow the above safety rules to be able to be in the shop.



# Your Team 2080 Safety Station



Torbotics maintains a fully stocked Safety Station.

It should be used for all First Aid needs.

Instructions for specific First Aid care is located in the Safety Station.

All Personal Protective Equipment is located in the Safety Station.

Team members should alert the Safety Captain whenever new supplies are needed for the Safety Station.

# Report of Safety Concern or Non-Medical Incident

Team 2080 is committed to the safety and development of each team member.

Should you feel uncomfortable about a peer interaction, unsure of how to proceed with a conflict or witness an injustice, we want to hear about it.
